## Principle 1: Freedom for children to experience environments that consider their needs

- ✓ Driver of change- challenge/prompt over time
- ✓ Children need to know structures and how they can be heard
- ✓ Forums are a good way to engage and hear children voices

# Principle 2: Respect and dignity for children to express their individual opinions, participate in and contribute to decisions about their communities and wellbeing

- ✓ Youth councils, children's advisory groups
- ✓ Importance beyond consultation
- ✓ How do you engage under six years of age and the disengaged?

# Principle 3: Equitable access to supportive environments and services for children regardless of gender, ethnicity, religion or ability

- ✓ Really clarify what children mean
- ✓ How do you access children safely?
- ✓ MCH bus at Brimbank
- ✓ Push boundaries- look outside the box
- ✓ Registering events- how are you making if child friendly' question added
